Off-Campus Living Request & Registration

2014-2015 Academic Year

ALL Applicants: Current Academy policy allows students who fit defined categories to apply to live off campus by **completing** and submitting this form. *This is not an appeals form* (refer to Academy Catalog and Student Handbook for information on residency requirements and appeals).

Your application must be filled out completely and returned in a timely manner to the Director of Residential Life & Student Services via their campus mail box located in the Commandant's Office Suite: 135 Curtis Hall. When you submit your request, you must be prepared to prove eligibility. If you are not approved you will be notified within one week of receipt of your form.

New Students: All new students must submit their Off-Campus Living Request & Registration no later than two weeks after the first class day of their first semester. Failure to do so may result in a \$200.00 room cancellation fee. <u>New Regimental students planning to live off-campus will meet with a Company Officer during New Student Orientation or Regimental Preparatory Training.</u>

Returning Students: Those returning students who sign up for campus housing during the Spring Housing Selection and then decide to move off-campus must submit <u>completed</u> requests no later than July 1st for Fall or the Last Day of Fall Classes for Spring. Those who submit completed forms after those dates are subject to a \$200.00 room cancellation fee. Those who submit forms after August 1st or January 1st for Fall or Spring Semesters, respectively, are subject to a \$400.00 surcharge. <u>Returning Regimental students must meet with their Company Officer prior to submitting their request.</u>

Students who occupy rooms temporarily will be charged pro-rated fees for room and board (required) based on when they moved off campus. (**Temporary housing will be on a space available basis.**) The date that you vacate Curtis Hall and successfully complete your check-out with the Residential Coordinator will determine your pro-rate.
