- Iron (can be shared with roommate)
- Any items required for participation in athletics
- Laptop Computer (Restricted use during RPT)
- Phone (Restricted use during RPT)
- Alarm clock (Restricted use during RPT)
- Free standing fan
- Medications

Optional Items to Bring August 17th but only to unpack AFTER RPT:

- Floor or desk lamp
- Study and school supplies (notebooks, pens, calculator, etc)
- Desktop printer
- Foam "egg crate " mattress pad
- One (1) poster
- One (1) framed picture

Items NOT allowed during the Fourth Class (First) Year:

- TV, DVD player
- Microwaves
- Refrigerators
- X box, PlayStation, Nintendo, etc.
- Coffee maker
- Closed-coil hot water heater
- Additional Furniture
- Pets
- Hot plates or electric grills
- Electric blankets, heating lamps, or pads
- Toasters or toaster ovens
- Candles and/or incense
- Halogen lamps OR any lamp with plastic shades
- Appliances not approved by Underwriter Laboratories (UL)
- Window or stand-alone air conditioning unit
- Sound system
